Safeguarding data Protection in an Open data World (SPOW)

- A new legal construct (a balancing model) that supports the benefits and protects the interests of **open data** and **data protection**

Open data

1. Data Must Be Complete
2. Data Must Be Primary
3. Data Must Be Timely
4. Data Must Be Accessible
5. Data Must Be Machine processable
6. Access Must Be Non-Discriminatory
7. Data Formats Must Be Non-Proprietary
8. Data Must Be License-free
9. Compliance must be reviewable
10. The work shall be available as a whole and at no more than a reasonable reproduction cost

Or simply

- Data without any restrictions in the (re-)use and provided for free

Data protection in the EU


- Data Protection Directive (EC/95/46) provides the conditions for processing personal data (now: General Data Protection Regulation)

If Directive applies then:

- Personal data should be collected for *specified, explicit* and *legitimate purposes* and not further processed in a way incompatible with those purposes.
